

Assignment and Transfer of Copyright Ownership

5. The rights granted to Assignee include the right to publish the Copyrightable Art Work on media, including, but not limited to, tangible merchandise, advertisements, paperwork, websites, social media, whether the items are to be for sale, profit or not. Assignee has the full and sole rights to any and all profits from any and all sales of media and merchandise depicting the Copyrightable Art Work.
6. Assignee may publicly acknowledge that Assignor was the original artist/creator of the Copyrightable Art Work. However, this does not change the terms of this written agreement wherein Assignor irrevocably assigns and transfers to Assignee all of Assignor's right, title, and interest in the Copyrightable Art Work described and attached as Exhibit A to this Assignment.
7. Assignor hereby waives any and all moral rights claims associated with the Copyrightable Art Work including, but not limited to, the right to be known as the creator/author, the right to object to any alterations to a work, the right to prevent others from being named as the creator/author of a work, the right to prevent others from attributing to one the authorship of a work that one has not created, the right to prevent others from making changes in a work, the right to withdraw a published work from distribution if it no longer represents the views of the creator/author, and the right to prevent others from using a work or the creator's/author's name in such a way as to reflect on the creator's/author's professional standing.

8. This Assignment is governed by the laws of the State of Florida without regard to its conflict of law rules.
